## **2023 MEMBERSHIP CATEGORIES**

**Regular Membership:** A full family membership limited to the following: a husband, wife, and children; a father and children; or a mother and children. A child is defined as a son or daughter eighteen years old or nineteen to twenty-three years old if attending a day school beyond the high school level as a full-time student. All must be listed as Dependents on your Income Tax Return. Privileges include the full use of all Club facilities. Monthly restaurant minimums apply to this membership. \$100.00 Initiation/Application Fee Required

**Social Membership:** A full family membership. Privileges include full use of all Club facilities except the golf course. Monthly restaurant minimums apply to this membership. \$50.00 Initiation/Application Fee Required

**Non-Resident Membership:** A full family membership defined as a member who lives outside of a 10 mile radius of the city limits of Sikeston. Privileges include full use of all Club facilities. Monthly restaurant minimums apply to this membership for the 6 month golfing period, April through September. \$100 Initiation/Application Fee Required

**Junior Membership:** Any person aged twenty-nine (29) or less. Privileges include full use of all Club facilities. Junior Members become Regular Members on their thirtieth (30) birthday. Monthly restaurant minimums apply to this membership. \$100 Initiation/Application Fee Required

**Swimming Membership:** A full family membership allowing full use of the swimming pool and clubhouse for the period of time the swimming pool is open, Memorial Day through Labor Day. Monthly restaurant minimums do not apply. \$25 Initiation/Application Fee Required

**Capital Improvement Fee:** A Capital Improvement Fee is charged all members as follows: Regular and Non-Resident Membership \$10.00/month; Social Membership \$3.00/month; Swimming Members \$30.00/summer; and Junior Members \$5.00/month. The fee is invoiced on the same time frame as member's dues.
